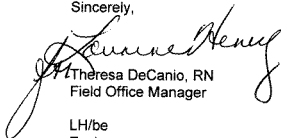
This letter reports the findings of a state licensure ECC survey revisit conducted on August 28, 2014 by representative(s) of this office.
