**SUMMARY STATEMENT OF DEFICIENCIES
(FINDINGS PRECEDED BY TAGS AND REGULATORY IDENTIFYING INFORMATION)**

0000 - Initial Comments

On [redacted] an unannounced Revisit to CCR#2015001756 (in conjunction with a revisit to Biennial with Extended Congregate Care and new Extended Congregate Care Monitoring) was conducted at Broadview Assisted Living Facility. At the time of the survey the deficient practice was not corrected.

0152 - Physical Plant - Safe Living Environ/Other - 58A-5.023(3) FAC

Based on observation and interview with the Executive Director and Vice President of Operations Eastern Division, the facility failed to ensure upon the revisit that residents living on the second floor of the facility lived in a clean environment regarding the carpeting.

The Findings:

On [redacted] at approximately 8:15 am, an observation was made of the second floor to find that the carpeting had not been repaired. The carpeting in heavy traffic areas was observed to have large, dirty stains and in poor repair. On [redacted] at approximately 10:11 am an interview was conducted with the Executive Director (ED) who reported that the facility has the carpet cleaned monthly. The ED stated that after the complaint survey she talked with the Chief Operating Officer of the company and plans are underway to change out the carpet. The ED stated that measurements have been taken, carpet samples have been selected and now the facility is just waiting for the check to be cut. The Executive Director could not provide documentation to support the information. When asked if the Corporate Office would have documentation, she was not sure.

On [redacted] at approximately 10:20 am an interview was conducted with the Vice President of Operations Eastern Division, who was present in the facility, and confirmed the information given by the Executive Director, but was not able to provide any documentation to support that the facility had a vendor to come out and make measurements. The Vice President was not sure of the estimated date for completion of the carpeting.
