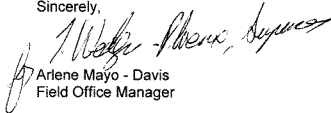
This letter reports the findings of a State Licensure Revisit Survey conducted on May 20, 2015 by a representative from this office.
