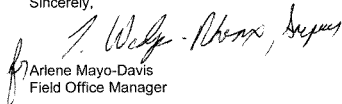
This letter reports the findings of a Extended Congregate Care (ECC) survey revisit conducted on July 1, 2015 by a representative of this office.
