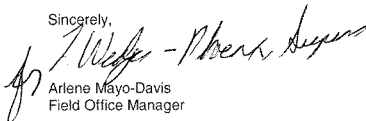
This letter reports the findings of a complaint survey revisit conducted on June 26, 2015 by desk review, by a representative of this office.
