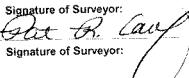

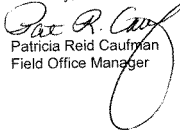
This letter reports the findings of a state licensure follow-up (desk review) conducted on July 9, 2015, by representative(s) of this office.
