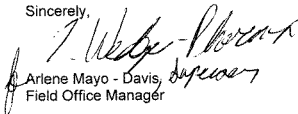
This letter reports the findings of a State Relicensure Revisit Survey conducted on August 11, 2015 by a representative from this office.
