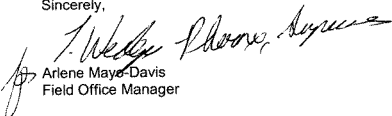
This letter reports the findings of a state Relicensure survey revisit conducted by desk review on September 4, 2015 by a representative of this office.
