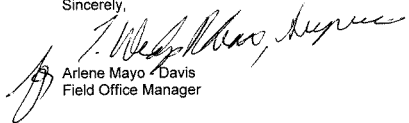
This letter reports the findings of a State Relicensure Revisit Survey conducted on September 8, 2015 by representative from this office.
