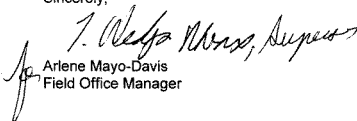
This letter reports the findings of a state licensure survey revisit conducted on September 8, 2015 by a representative of this office.
