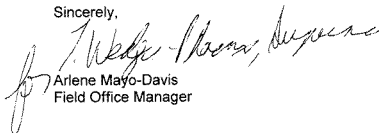
This letter reports the findings of a complaint survey revisit conducted on September 17, 2015 by a representative of this office.
