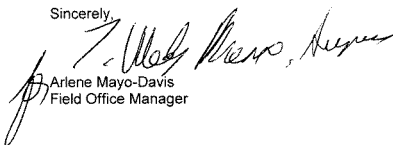
This letter reports the findings of a monitoring survey revisit conducted on December 9, 2015 by a representative of this office.
