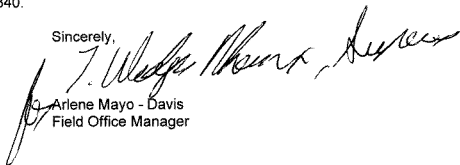
This letter reports the findings of a State Licensure Revisit Survey conducted on December 8, 2015 by a representative from this office.
