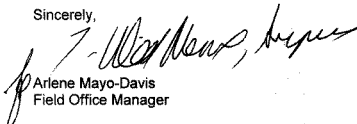
This letter reports the findings of a state Relicensure survey revisit conducted on January 14, 2016 and January 19, 2016 by representative of this office.
