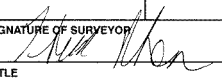

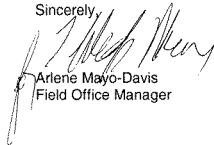
This letter reports the findings of a state licensure survey revisit conducted on November 2, 2015 by a representative of this office.
