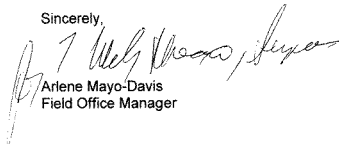
This letter reports the findings of a Relicensure/CHOW survey revisit conducted by desk review on January 27, 2016 by a representative of this office.
