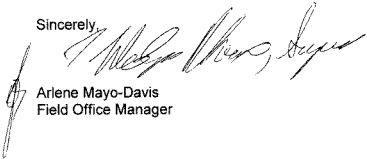
This letter reports the findings of a state Relicensure survey revisit conducted on January 28, 2016 by a representative of this office.
