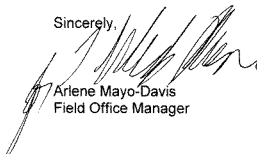
This letter reports the findings of a Monitoring survey revisit conducted on January 25, 2016 by a representative of this office.
