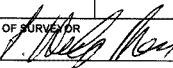

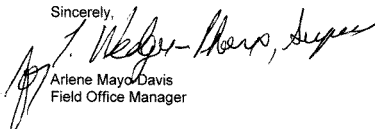
This letter reports the findings of a state licensure survey revisit conducted on January 26, 2016 by a representative of this office.
