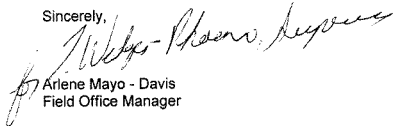
This letter reports the findings of a State Standard Licensure Revisit Survey conducted on March 11, 2016 by a representative from this office.
