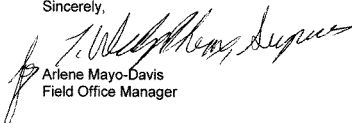
This letter reports the findings of a state licensure survey revisit conducted on March 16-17, 2016 by representatives of this office.
