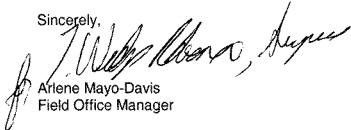
This letter reports the findings of a state licensure survey desk review conducted on April 13, 2016 by a representative of this office.
