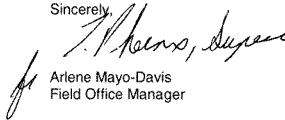
This letter reports the findings of a state complaint licensure survey revisit conducted on May 18, 2016 by a representative of this office.
