0000 Initial Comments

An unannounced Extended Congregated Care (ECC) monitoring survey was conducted on 05/19/2016 at Abbey Delray Health Center, Assisted Living Facility. The facility had a deficiency found at the time of the visit.

Z814 Background Screening Clearinghouse

Based on observation, interview and record review, the facility failed to maintain an employee roster with the employment status of all employees of the facility within the background screening (BGS) clearinghouse.

The findings include:

A record review of the employee roster for the facility on the Agency for Health Care Administration Care (AHCA) Provider Background Screening Clearinghouse website was conducted on at 3:23 PM. It was noted the facility had no employees listed on the roster.

Review of the facility staffing schedule for 2016 indicated that there are care staff scheduled to work on the Assisted Living wing of the facility, including the Director of Nursing and nursing staff.

In an interview with the Executive Director/ Acting Administrator on at 12:30 PM, she stated that she was unaware that the names of the facility's employees had not been placed on the background screening clearinghouse employee roster list as required. She stated she would immediately update the employee roster.
