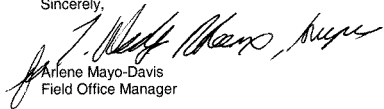
This letter reports the findings of a state licensure survey revisit conducted on March 11, 2016 by desk review by a representative of this office.
