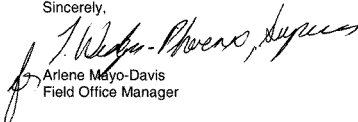
This letter reports the findings of a state licensure survey second revisit conducted on June 23, 2016 by a representative of this office.
