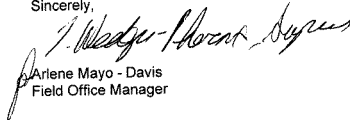
This letter reports the findings of a State Relicensure Revisit Survey conducted on June 29, 2016 by a representative from this office.
