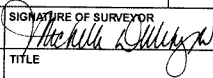

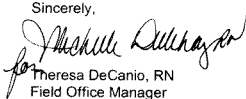
This letter reports the findings of a state licensure complaint survey revisit conducted on July 12, 2016 by representative(s) of this office.
