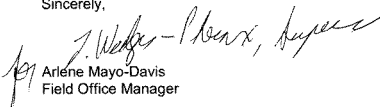
This letter reports the findings of a state licensure survey revisit desk review conducted on July 28, 2016 by a representative of this office.
