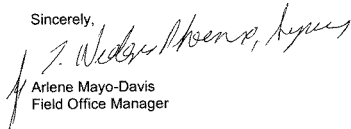
This letter reports the findings of a state licensure survey desk review revisit conducted on August 3, 2016 by a representative of this office.
