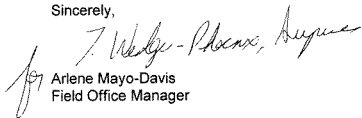
This letter reports the findings of a complaint survey second revisit conducted on August 10, 2016 and August 11, 2016 by a representative of this office.
