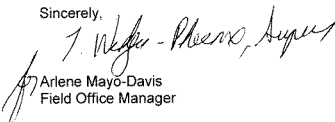
This letter reports the findings of a state Relicensure survey revisit conducted on August 31, 2016 by a representative of this office.
