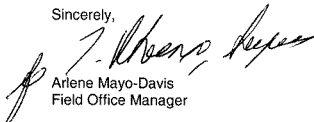
This letter reports the findings of a state licensure survey revisit conducted by desk review on September 7, 2016 by a representative of this office.
