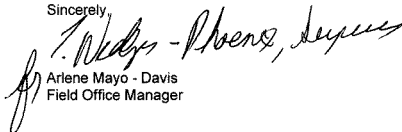
This letter reports the findings of a State Licensure Revisit Survey conducted on September 7, 2016 by a representative from this office.
