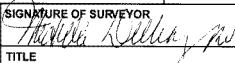

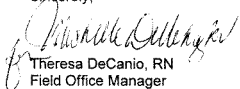
This letter reports the findings of a state licensure complaint investigation survey revisit conducted on September 27, 2016 by representative(s) of this office.
