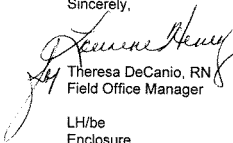
This letter reports the findings of a state licensure complaint investigation survey revisit conducted on September 29, 2016, by representative(s) of this office.
