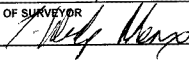

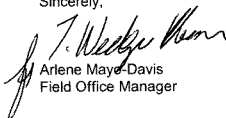
This letter reports the findings of a state licensure survey second revisit conducted on October 10, 2016 by a representative of this office.
