Based on record review and interview the facility failed to file a 1 day and the 15 day incident report for a missing resident that was reported to law enforcement (Resident # 11).

Findings included:

Record review revealed that the facility did not file an incident report for Resident #11 who went missing from the facility on 12/14/2016. The incident was reported to law enforcement but the facility did not have a completed adverse report.

On 12/14/2016 at 10:32 am the facility administrator stated, "We will have it corrected today."
