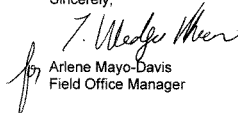
This letter reports the findings of a state licensure survey revisit conducted by desk review on December 20, 2016 through December 29, 2016 by a representative of this office.
