This letter reports the findings of state licensure survey revisit conducted on January 12, 2017 by representative(s) of this office.

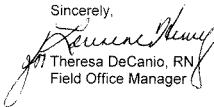
The previously cited deficiencies were found corrected on the day of the revisit.
