Record review of the employee file for Employee B found she was hired as a caregiver on, terminated on, and rehired on Further record review found no evidence of a new application. The most recent Level II screening was dated

During an interview with the Administrator on at 1:54 PM, she stated Employee C was terminated because she left the stated to take care of and ill family member and when she came back to Florida she came back to work at the facility. The Administrator called the Business Office Manager and confirmed that a new level II screening was not completed.
