0078 - Staffing Standards - Staff - 58A-5.019(2) FAC

Based on personnel record review and interview the facility failed to have evidence that 1 of 1 sampled staff (F) had provided a statement from a health care provider documenting freedom from communicable and ()

Findings:

Review of the personnel record for Staff F, hired, was found not to contain documentation that she was free from communicable and

In an interview with Staff F on at 10:30AM, she stated she had not gotten to the doctor yet.

In an interview on at 11:10AM with Staff B, assistant to the administrator, she confirmed the documentation was not available for review.

0081 - Training - Staff In-Service - 58A-5.0191(2) FAC

Based on personnel record review and interview the facility failed to have evidence that 1 of 1 sampled staff (F) received the required in-service training within 30 days of hire.

Findings:

Review of the personnel record for Staff F, hired, was found to not contain certificates for training in Residents Rights or Nutritional and Safe Food Handling.

In an interview on at 11:10AM with Staff B, assistant to the administrator, she confirmed the certificates were not present. She stated she would make sure Staff F got the training.

Based on personnel record review and interview, the facility failed to ensure 1 of 1 sampled staff (F), who was in a role that required a background screening, had a copy of the eligibility results of employee screening in the staff's personnel file.

Findings:

Staff F was hired on . The background screen in the personnel file was from , but there had been a lapse in employment of more than 90 days since the screening.
Review of the Agency background screening website revealed that staff F did have a new screening with an "Eligible" result on A copy of the recent screening was not in the personnel file .

In an interview with the assistant manager, Staff B, on at 11:10 AM, she confirm the document was not in the file and stated they had just not gotten around to printing out the new results yet.
