Z817 - Minimum Licensure Requirement - Inform AHCA - 408.810(3-4) FS; 59A-35.100(1) FAC Based on observation, interview and record review, the facility failed to inform the Agency (AHCA) 30 days prior to discontinuing operation as an assisted living facility and failed to surrender the facility's license upon discontinuing operation. Findings included: On , a review of the Agency's licensure database and of the Agency's website, Floridahealthfinder.gov, revealed that the facility was currently listed as licensed and their assisted living facility license expired . On beginning at 8:45 AM at the facility, the following was observed: the front door was locked and inaccessible, there was no response to a doorbell, lights were off inside, attempts to contact the telephone number posted on the door were unsuccessful. On at 9:05 AM, an adult male who stated he resided at the location said the location is no longer operating as a licensed assisted living facility and no longer serves meals. On at 9:05 AM, an adult female who appeared to work at the location said the location is no longer an assisted living facility and is now operating as a hotel. On at 1:15 PM, an e-mail was received from the Agency's Central Office. The e-mail indicated the Agency had received no correspondence or communication from the facility indicating they planned to close. The e-mail also confirmed the facility had not surrendered their license. On , the Agency received an e-mail from the licensee of the facility after the Central Office sent correspondence. The e-mail indicated the facility had discontinued operation and wished to give up their license. Unclassified
