Findings:

Personnel record review for staff A revealed a hire date of in the capacity of a caregiver.

Personnel record review for staff C revealed a hire date of in the capacity of a caregiver.

The records did not contain evidence to indicate staffs A and C submitted a statement from a healthcare provider that indicated freedom from communicable including , as required.

Based on personnel record reviews and interview, the facility failed to ensure 1 of 4 direct care staff (A) obtained level 1 training within three months of employment.

The record contained no documented evidence to indicate staff A obtained 4 hours of initial training entitled " and Related Level 1 Training" within three months of employment, as required.
