Any device, including half-bed rails, which the resident chooses to use and can remove or avoid without assistance, is not considered a physical _____. 429.28 Resident bill of rights.- (1) No resident of a facility shall be deprived of any civil or legal rights, benefits, or privileges guaranteed by law, the Constitution of the State of Florida, or the Constitution of the United States as a resident of a facility. Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from _____ and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individuality, and the need for privacy. (c) Retain and use his or her own clothes and other personal property in his or her immediate living quarters, so as to maintain individuality and personal dignity, except when the facility can demonstrate that such would be unsafe, impractical, or an infringement upon the rights of other residents. (d) Unrestricted private communication, including receiving and sending unopened correspondence, access to a telephone, and visiting with any person of his or her choice, at any time between the hours of 9 a.m. and 9 p.m. at a minimum. Upon request, the facility shall make provisions to extend visiting hours for caregivers and out-of-town guests, and in other similar situations. (e) Freedom to participate in and benefit from community services and activities and to achieve the highest possible level of independence, autonomy, and interaction within the community.	A 030

(h) Reasonable opportunity for regular exercise several times a week and to be outdoors at regular and frequent intervals except when prevented by inclement weather. (i) Exercise civil and religious liberties, including the right to independent personal decisions. No religious beliefs or practices, nor any attendance at religious services, shall be imposed upon any resident. (j) Access to adequate and appropriate health care consistent with established and recognized standards within the community. A 030	Continued From page 5 the laundry discolored with a reddish brown substance. Ceiling tiles in the washing area of the laundry cracked and discolored with a circular reddish brown substance. The ceiling tile above and to the left of a washing machine was missing and the surrounding ceiling tile was discolored with a dark brown substance. In the washing area of the laundry . . . , the light cover was loose and hanging down from the ceiling. In the dryer . . . , a ceiling tile was pushed upward from the frame over the far left dryer. The tile was discolored with a dark blackish brown substance. The wall behind the folding table and hanging clean clothes was discolored with a streaked black substance. There were holes in the wall in the dryer the exterior exit above and below the wooden wall trim (photographic evidence obtained).
