0000 - Initial Comments

An unannounced Relicensure survey was conducted on at Advantage Senior Living Facility, LLC, License #10472. The facility had deficiencies at the time of the visit.

0093 - Food Service - Dietary Standards - 58A-5.020(2) FAC

Based on observation, interview and record review, the facility failed to ensure that a 3-day supply of nonperishable food, based on the number of weekly meals the facility has with residents to serve, be on at all times for 6 of 6 sampled residents in the facility (Specifically, Resident's # 1 - # 6).

The findings included:

On at 12:20 PM, an observation was made of the 3-day emergency food supply located in an outside storage shed along with the facility Administrator. At this time, the food available was compared to the Disaster Food Supply List prepared by the Facility's Certified Dietitian. It was reveal that the food on was not consistent with the items on the list. The following was observed:

Food Item-Assorted Fruit Juice, Recommended-192 oz., Available-128 oz.

Food Item-Evaporated Milk, Recommended-384 oz., Available-168 oz.

Food Item-Chili with Beef, Recommended-64 oz., Available-0

Food Item-Beef Stew/Chicken dumpling, Recommended-64 oz., Available-0

Food Item-Peanut Butter, Recommended-24 oz., Available-0

Food Item-Mixed Vegetables, Recommended-96 oz., Available-0

Food Item-Carrots, Recommended-96 oz., Available-0

Food Item-Peaches, Recommended-32 oz., Available-0

Food Item-Pears, Recommended-32 oz., Available-0

On at 12:45 PM, an interview was conducted with the Administrator. She stated she was going to the store to obtain the items. Class Z816 - Background Screening-Compliance Attestation - 408.809(2)(a-c); 59A-35.090(2)(d)-(3) Based on interview and record review, the facility failed to provide proof of the the Background Screening Attestation Compliance form, for 1 of 3 sampled staff member records reviewed (Staff A). The findings included: On a review of the employee personnel files was conducted. It was revealed that Staff A, who was hired on as a Caregiver to provide direct care to residents in the facility; did not have the Background Screening Attestation form accompanying her Level II Background screening from the Background Screening Clearing House. On a side-by-side interview was conducted with the Administrator. She searched the records and was unable to locate the Attestation form. She stated that she was sure she had it previously.
