This Statute or Rule is not met as evidenced by: Based on records review and interview, the facility - who has unlicensed staff assisting residents with the self-administration of medications, failed to provide a written informed consent and retain a written and signed consent form in the records for 1 of 2 residents (Resident #5), whose records were reviewed. Findings included: A review of Resident #5's record was conducted on The record, including the resident contract, was missing any written informed consent form, letting the resident or their representative know that the facility had unlicensed staff assisting residents with the self-administration of medications. In an interview with the Assistant Administrator at 3:30pm, the Assistant Administrator stated she was not aware that there was a requirement for an informed consent form. She looked through Resident #5's record and was not able to find an informed consent form. The Assistant Administrator stated she is not the one who is responsible for resident contracts.
