During the survey, the SA investigated neglect, pressure sores, quality of care/resident safety, quality of care/not groomed adequacy with no deficiencies cited; however, the facility remains out of compliance with the requirements for participation in Medicare and Medicaid due to deficiencies cited on the 09/28/23 and 10/18/23 surveys.
