CI MS #23608 was investigated related to abuse, CI MS #23597 was investigated related to misappropriation of property, and CI MS #23592 was investigated related to neglect. During the survey, the SA determined that the facility was in compliance with the requirements for participation in Medicare and Medicaid and no deficiencies were cited.
