F 000	INITIAL COMMENTS The State Agency (SA) conducted three (3) Complaint Investigations (CI MS #24148, CI MS #24172, and CI MS #24161), at the facility from 02/15/24 through 02/16/24. CI MS #24148 was investigated related to resident's allegation of abuse. CI MS # 24172 was investigated related to facility abuse and neglect of a resident. CI MS #24161 was investigated regarding no warm water in resident's rooms and shower rooms, plumbing issues, inadequate staffing, verbal abuse, and denied privileges to go outside. During the survey, the SA determined the facility was in compliance with the requirements for participation in Medicare and Medicaid and there were no deficiencies cited. However, the facility remains out of compliance due to deficiencies cited on the 01/09/2024. The facility held a license for 180 beds, with a census of 158.	F 000
